WAYS TO GIVE

CHARITABLE BEQUEST

A charitable bequest will distribute your special gift from your estate to the NHSM through your last Will and Testament. It can be in the form of a fixed amount or a percentage of assets from a settled estate.

LIFE INSURANCE

There are two options for gifting through life insurance:

- Name the NHSM as the owner and irrevocable beneficiary – you will receive a tax receipt related to the fair market value, and an annual tax receipt for the value of the premium going forward.
- Name the NHSM as a beneficiary and continue to own the policy – your estate will benefit from a charitable receipt for the value of the proceeds receivable by NHSM.

SECURITIES

You can transfer your shares of publicly traded securities directly to the NHSM and will not pay tax on your gain. You will receive a charitable tax receipt for the market value of the securities on the day of settlement.

RRSP AND RRIF

Name the NHSM as a partial or full beneficiary of your RRSP or RRIF. The charitable receipt can be applied up to 100% of net income in the year of death and the preceding tax year.
